# Environmental Policy

---

Atac Solutions are committed to environmental affairs leadership in every aspect of what we do. Atac is dedicated to protecting human health, natural resources and the local and global environment, in accordance with the Environmental Principles.

In particular, Atac Solutions will strive to achieve the following objectives through continued execution of our Environmental Management System:

- Comply with all applicable environmental laws and regulations, and other requirements.
- Assign management responsibility for the environment in all areas of our facilities and ensure that all employees are aware of their individual responsibilities for acting in accordance with this policy.
- Practice and promote effective prevention of pollution, elimination or reduction of wasteful practices, and recycling

## *Energy Use*

Staff at Atac should ensure the responsible use of energy throughout, including conserving energy, improving energy efficiency, and giving preference to renewable over non-renewable energy sources when feasible. To support this objective we ensure the following are adhered to.

- Lights are turned off when not in use, and are all switched off overnight. Where natural light is adequate lights are also switched off. Posters are placed up within the building to remind employees of this.
- Ensuring computers are switched off at the end of the working day, not left on sleep mode.
- Air conditioning and heating is not excessively used, and turned off when appropriate.
- Energy efficient equipment replaces any equipment that is needed to be replaced.
- Ensuring that company premises are well insulated and energy efficient.

## *Recycling and Re-use of Materials*

Atac will promote the recycling and re-use of waste materials, by-products or equipment wherever possible. The company is committed to recycling products wherever this is viable. Metal, paper, cardboard, electrical goods and ink and toner items should all be recycled. The expectation is that staff should use recycling bins provided. Where the company retires any old equipment it will consider whether the equipment or its components can be sold or donated to interested parties rather than being disposed of.

Atac ensure that any waste water produced is disposed of in the correct manner. Where possible, we redesign processes to eliminate or reduce chemical use and substitute more environmentally preferable chemicals. Atac also focus for decades on preventing the generation of non-hazardous waste, and where this is not practical, recovering and recycling the materials that are generated. Non-hazardous waste includes paper, wood, metals, glass, plastics and other non-hazardous chemical substances.

All of the employees are ATAC Solutions Ltd are encouraged to abide by our Environmental Policy, and it is integrated into our new employee induction schemes.
